Any student permitted to enrol after the designated enrolment window as per the enrolment dates above will be required to pay a Late Enrolment fee.

## PARKING FEE | R 1 000

On-campus parking disc. Applicable to all new or returning students (all Higher Certificate students as well as all first-year, second-year and third-year Degree Programme students). Postgraduate students are not required to pay for parking.
